## Special Board of Directors Meeting/Budget Adoption

The meeting was called to order & Pledge of Allegiance led by Chairperson Jennifer Staggs at 7:00 PM.

Secretary Jeff Snodgrass read the minutes of the September 5th, 2018 Board meeting. Motion to approve as presented was made by Director Dotson, seconded by Vice Chairman Allbritten, and the vote to approve was unanimous.

Financial Clerk Kelly Stege was on vacation and not able to attend the meeting. Report and Payment of Bills was given by Chairperson Staggs. ## **New Business**

Chairperson Staggs stated that Jeff Fox from CB Burke will come to Jan 8, 2019 meeting to address questions concerning the silt management plan that they provided a bid for. We will include a notice in the December election mailing to all freeholders.

Chairperson Staggs announced the exit interview for our audit with the State Board of Accounts will be scheduled for October 17<sup>th</sup> or 18<sup>th</sup>. Chairperson Staggs and Financial Clerk Stege will represent the LECD Board, and will update the rest of the board at our November 13<sup>th</sup> 2018 meeting. Preliminary indications show no major concerns.
