It's boat registration time again! Although if you cannot make one of the dates below. We can still process your registration if dropped off in the slot at the clubhouse. Incomplete forms will cause a delay. No cash please. **Please make sure you submit the homeowner's insurance declaration page that includes the policy # and shows the coverage amount.** This is under your homeowner's policy. We do not need to see insurance coverage on your actual boat.

**Option #1** Freeholders can complete the attached forms and ***drop them in the slot on the Clubhouse door*** any time after receiving this registration form. Your Board of Directors will process the forms and your stickers, ramp access and flags will be delivered to you when complete.

**Option #2** We will be having three in person registrations this year.

**Incomplete or incorrect information will result in a delay in getting your stickers/ramp access/flags. If you have any questions, please contact your LECD Director.**

**The freeholder must include the following:** 1) the completed LECD Watercraft ID Form and Boat Registration Form 2) proof of financial liability insurance (certificate of insurance), and, 3) check (payment)for the required fees. Please, make every effort to use these dates and times, as the directors will be unavailable at random times to register your watercraft.

**Proof of insurance is required and all watercraft must be individually registered to a Lake Edgewood Freeholder.**

Transferring stickers between watercraft is not allowed. All fees are due and payable **on or before May 9th, 2023** or prior to the launching of any presently unregistered watercraft.

**Complete forms in full and sign confirmation rules have been read and are agreed upon.** (see attached forms)

**Current proof of financial liability must be provided for any operating watercraft on Lake Edgewood.** A minimum of \$300,000 watercraft liability on your watercraft insurance is required for any single unit watercraft, whether powered by gasoline motors, electric or human or a minimum of \$300,000 personal liability on your homeowner's policy for your watercraft (s). Evidence of this coverage is required before a license (sticker) or ramp access can be issued. Your insurance agent can provide a current certificate or declarations sheet. All watercraft used on the lake must be covered.

**Off Lake Property Owners Dock Users in Birdhouse Cove** must renew user agreements by May 9th, 2023. You can renew the agreement at the Community Center when you register your watercraft. Your Certificate of Insurance for the docks is also required before issuing an agreement or stickers.

Orange flags are required for any craft that pulls skiers, boarders etc.

**IMPORTANT NOTICE AS REGARDS WATERCRAFT INSURANCE and LAKE USAGE: Proof of financial liability must be provided for any watercraft on Lake Edgewood. A minimum of \$300,000 watercraft liability on Insurance is required for all watercraft (gasoline, human or electric powered watercraft), or a minimum of \$300,000 personal liability on your homeowner's policy. Evidence of this coverage is required before a license (sticker) can be issued. Please, provide the financial officer with a Certificate of Insurance. Your insurance agent can provide a current certificate or declaration sheet for you. Additionally, your signature below verifies that you, 1) have agreed to review and adhere to the LECD Lake Usage rules and regulations and 2) understand the risks involved when boating and swimming in said "Lake Edgewood".**
